Terms and Conditions

These Terms and Conditions govern your participation in social media competitions, free draws, and cash giveaways organized by lock stock competitions. By entering our competitions, you agree to be bound by the following terms and conditions.

1. Eligibility

- 1.1. Entrants must be aged 18 or over and reside in United Kingdom.
 - 1.2. Employees of lock stock competitions, their family members, or anyone professionally connected with the competition are not eligible to enter.
 - 1.3. Only 1 entry per person per competition is allowed unless otherwise specified. Multiple entries will be disqualified

2. Entry Requirements

- 2.1. Entries must be made through our social media platforms or the official competition entry page as instructed.
 - 2.2. For paid competitions, entrants must complete the payment using a valid payment method processed by our payment acquirer.
 - 2.3. No responsibility is accepted for entries not successfully completed due to technical issues, network errors, or any other reason beyond our control.

3. Competition Details

- 3.1. Each competition will have specific entry instructions, a skill/knowledge-based question, opening and closing dates, prize descriptions, and other relevant details which will be made clear in the competition post or announcement.
 - 3.2. Free draws do not require a payment for entry, but entrants may be required to follow specific instructions, such as liking or sharing a post, tagging friends, or subscribing to our social media channels.
 - 3.3. Cash giveaways will be transferred to the winner's nominated bank account within 2 business days after the competition ends, provided that all required details have been supplied.

4. Prizes

- 4.1. Prizes will be specified in the competition or free draw post. Prizes are non-transferable and cannot be exchanged for cash or alternatives unless stated otherwise.
 - 4.2. If a cash prize is won, it will be paid via bank transfer to the account provided by the winner.
 - 4.3. We reserve the right to substitute a prize of equal or greater value if the original prize becomes unavailable.
 - 4.4. Prizes that require physical delivery will be sent via a third-party courier or delivery company, and all prizes must be signed for upon delivery. If the recipient is not available to sign, it is the responsibility of the winner to arrange redelivery.
 - 4.5. We are not responsible for any delays in delivery or issues caused by the third-party courier service. However, we will assist in resolving delivery issues as much as reasonably possible.

5. Winner Selection and Notification

- 5.1. The winner will be chosen at random from eligible entries unless otherwise specified in the competition instructions.
 - 5.2. Winners will be notified via direct message on social media or by email within 1 day of the competition closing. The winner must respond within 72 hours to claim their prize.
 - 5.3. If the winner does not respond within the specified timeframe, they will forfeit the prize, and another winner will be selected.
 - 5.4. Winners may be required to provide proof of identity and eligibility before the prize is awarded.

6. Payments via Acquirer

- 6.1. Payments for entry into paid competitions must be made via our authorized acquirer using a valid debit or third party (Example Pay Pal)
 - 6.2. We do not store payment information directly. All payments are processed securely through our third-party payment acquirer, which complies with industry-standard security protocols.

7. Third-Party Involvement

- 7.1. Prizes sent through third-party delivery companies are subject to the terms and conditions of the courier. 147 INVEST LTD accepts no responsibility for any damage or loss



caused during transit.

7.2. Once a prize has been dispatched, responsibility for its safe delivery and condition lies with the third-party courier service.

7.3. Any complaints or claims regarding the delivery of a prize must be made directly to the courier company.

8. Publicity

8.1. By entering the competition, you agree that we may use your name, social media profile, and any related content for promotional purposes without additional compensation, unless prohibited by law.

8.2. Winners may be asked to participate in publicity and marketing, including sharing photos or testimonials about their prize.

9. Data Protection

9.1. We will collect, store, and process personal data in accordance with our [Privacy Policy/Data Protection Policy] and applicable data protection laws, including the GDPR.
